The presence of the applicant outside India may not, or is not likely to, prejudice the friendly relations of India with any foreign country.





force or an order prohibiting the departure from India of the applicant has not been issued by any such court.

- h) The applicant has not been repatriated.
- i) That there is no possibility of arising any embarrassing situation before the Government of U.P. or the Government of India due to my visit to any foreign country.
- j) That issue of 'Identity Certificate' for obtaining a passport has never been refused to me before.


