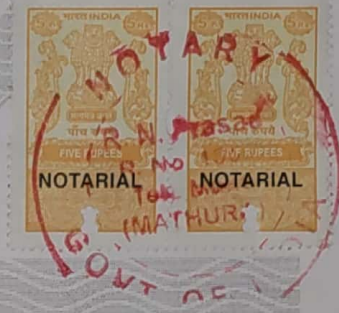

7. That a warrant or summons for the appearance, or a warrant for the arrest, of me has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court;
8. That I have not repatriated;
9. That there is no possibility of arising embarrassing position before Government of U.P. due to my visit to any foreign country;
10. That the issue of 'Identity Certificate' for obtaining a passport was never refused to me;
11. That I have visited my sister's place in Stockholm, Sweden in September, 2014 before joining Judicial services;
