Subject:- Case ID No. S00021752022 Relating to Permission expost-facto for NALSAR "Advance Diploma On Alternative Dispute Resolution systems

Sir,

I had applied for kind permission of the Hon'ble Court for appearing in the examination of the **NALSAR "Advance Diploma On Alternative Dispute Resolution systems 2021-2022** on my e services portal.

Hon'ble Court has been pleased to direct me to submit clarification on the points narrated below. My clarifications on the points so raised are as under:-

Point No.1: Clarify the reasons for informing about the said Course after completion of the same.

Clarification.1:This "**Advance Diploma On Alternative Dispute Resolution systems**" from **NALSAR ,Hyderabad** is a correspondence Course only. Due to prevailing COVID -19 situations in India and the world ,I got an opportunity to apply in the extended window of admission than the normal admission procedure & time .The admission was online. I got admission in October 2021 only. Since,I got the opportunity to study a relevant subject randomly & belatedly ,hence, I could not seek the prior permission of the Hon'ble Court before applying for the same. Further, due to COVID -19 situations following the admission & and official engagements, I missed the opportunity to apply for the permission just after the admission.

It is therefore, humbly prayed that in view of the nature of the course, permission expost facto may kindly be granted.

Point No.2: Intimate as to whether you have taken any study leave for rhe said Course /Exam .

Clarification.2: No study leave have been taken for the said Course. It is further pertinent to mention that no special leave was required as home study material /recorded lectures were supplied which could be listened/assimilated at the time suited to the student and hence, neither any official time or leave was required nor ever availed for the said course.

The Examination was held in the mode of "home Examination" from 10-06-2022 to 14-06-2022 & it fell between my officially permitted summer vacations in June 2022. Hence, no official leave was either required or obtained.

Point No.3: Intimate as to whether you have appeared in the said examination in anticipation of Hon'ble Court's permission .

Clarification.3: Yes. I have appeared for the said examination after informing the Hon'ble Court with prayer for appearing in the examination of said correspondence Course. & in anticipation of the permission of the Hon'ble Court.

It is further humbly submitted that the said course is from the most reputed National University (NALSAR) at Hyderabad and the said subject matter is relevant to the dispensation of Justice. In this regard ,it is relevant to mention that the JTRI,Lucknow has also organised lectures on Arbitration to provide adequate knowledge of the subject to the Judicial Officers and the said correspondence course is also related to the same subject matter. It is a purely academic activity .

Hence,It is prayed that my Case or matter may kindly be considered sympathetically.

The clarifications as directed are being submitted in all humility with a prayer for sympathetic consideration of the same. It is further prayed that ex-post facto permission may kindly be granted.
