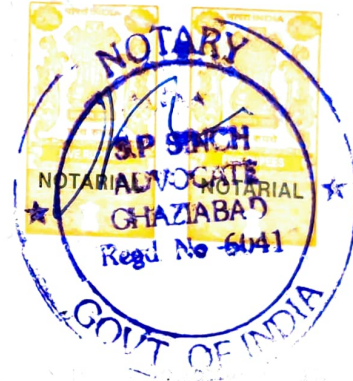
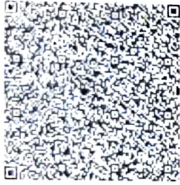


- (C) That the applicant may not or is not likely to engage outside India in activities prejudicial to the sovereignty and integrity of India.
