



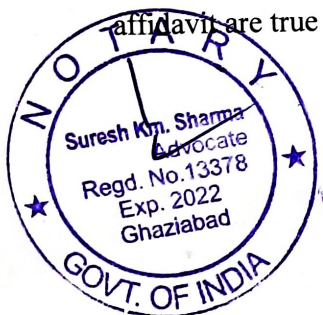
- (D) That the departure of applicant from India may not or is not likely to be detrimental to the security of India.
- (E) That the presence of applicant outside India may not or is not likely to prejudice the friendly relations of India with any foreign country.
- (F) That the applicant has, at any time during the period of five years immediately preceding the date of his application not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.
- (G) That the proceeding in respect of any offence alleged to have not been committed by the applicant are pending before a criminal court in India.
- (H) That a warrant or summons for appearance, or warrant for the arrest, of the applicant has not been issued by a court under any law of the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.
- (I) That the applicant has not been repatriated.
- (J) That there is no possibility of arising embarrassing position before Government of U.P. due to my visit to any foreign Country.
- (K) That issue of "Identity Card" for obtaining a passport was never applied by the applicant earlier.
- (L) That I have not visited any Foreign Country after joining the Higher Judicial Services in Uttar Pradesh.

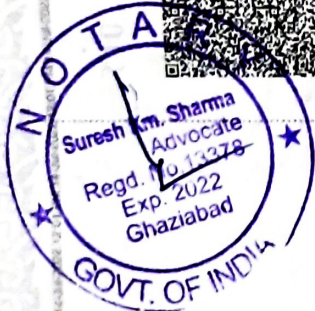
