Sub: Grant of three advance increments to those selected officers who are having Postgraduate Degree of LL.M. from a recognized University.

Madam/Sir,

With reference to Government's Order No. 1363/II-4-2009-45(12)/91 T.C. dated 13.05.2009, G.O. No. 1705/II-4-2011-45(12)/91 T.C. dated 03.01.2012 and G.O. No. 02/2015/355/II-4-2015-45(12)/91 T.C. dated 27.03.2015 read with G.O. No. 8/2018/279/II-4-2018-45(12)/91T.C. dated 13.04.2018 & G.O. No. 15/2018/940/II-4-2018-45(12)/91T.C. dated 18.09.2018 (copies enclosed for ready reference), on the above subject, I am directed to say that on consideration of above Government Orders, Hon'ble Court has been pleased to order that three advance increments with dearness allowance be allowed to the following eligible officers who possess qualification of LL.M. from a recognized University before or after joining the service, and either have mentioned this fact in the application form submitted at the time of recruitment to U.P Nyayik Sewa/U.P.H.J.S. or the LL.M. Degree included in their service records afterwards (his/her posting is mentioned against their names), either from initial date of joining in U.P. Nyayik Sewa/U.P.H.J.S., or w.e.f. 21.03.2002, or from the date of acquisition of qualification of LL.M. whichever is later on, and request you to take necessary action regarding fixation of pay of following concerned Judicial Officers and also to inform concerned Judicial Officers, posted in your Judgeship, accordingly :-
