With due respect, I beg to state that I, Pankaj Kumar, am currently posted as Additional Civil Judge (JD) F.T.C.(Civil) at District and Sessions Court Faizabad.

In compliance of Hon'ble High Court's CL No. No. 25/Admin. (A) dated 13 July 1998. Detail below is the serial wise information regarding purchase of new vehicle.

1. The undersigned joined the service on 16.12.2019 in pursuance to Hon'ble High Court's Notification no. 2104/Admin.(Services)/2021.
2. The undersigned on 20.10.2020 purchased MG Hector plus Sharp Diesel White Colour Model form Beeaar Autowheels India Pvt. Ltd. which bear registration no. UP 32 LS 0042. The said vehicle's on Road Price inclusive of Road Tax, Registration, Insurance, TCS, Accessories and service maintenance package is Rs. 22,29,817/- (Rupees Twenty Two lakh twenty nine thousand and eight hundred seventeen rupess only)
3. The Undersigned taken no loan from Hon'ble High Court for purchase of this vehicle.
4. The undersigned has taken loan of 10,00,000/- (Rupees Ten Lakh from Bank of Baroda, 2226 Fatehganj Branch, Annexe Hotel Krishna Palace, Faizabad-224001 to be repaid in 60 installments of Rs. 20,086/- (loan Account No. 22260600003107). Rs. 11,00,000/- (Rupees Eleven Lakh only) was paid through gifted amount of Rs. 11,00,000/- (Rupees Eleven Lakh only) which was transferred to my SBI account no. 20068806003

by my father, Shree Rama Nand, through Cheque no./ Ref no. 849319 (amount of rupees 6,00,000/- only) and Cheque no./Ref no. 849320 (amount of rupees 5,00,000/- only) from his account no. 11143426296 on 20.10.2020. The rest amount of 1,29,817/- was paid from my savings from SBI salary account, account no. 20068806003. The details of 1,29,817 are as follows:

- i. Rs. 50,000/- (Rs. Fifty thousand) was paid to the Car dealer, Beeaar Autowheels India Pvt Limited, on 4<sup>th</sup> October 2022 as advance payment for the booking of the Car through my SBI Account.
  - ii. Payment of Rs. 14737/- ( Rupees Fourteen thousand seven hundred and thirty seven ) was made on 20 October 2022 through my SBI Account towards TCS ( Tax Collected at source)
  - iii. Rs. 20000/- (Rs. Tweanty Thousand) was paid in cash for car accessories
  - iv. Rs. 45000/- (Rs. Forty Five Thousand) was paid from SBI account to Car dealer, Beeaar Autowheels India Pvt Limited, on 1st Nov. 2022 as payment towards purchase of 5 year car service plan for the vehicle.
5. The undersigned has not undertaken purchase of any second vehicle.
  6. The undersigned has not undertaken purchase of nay plot.
  7. The undersigned purchased the said vehicle from Beeaar Autowheels India Pvt Limited, IIIth Milestone, Ground Floor, Faizabad Road, Chinahat, Lucknow-227105.
  8. The undersigned is not related to seller Beeaar Autowheels India Pvt Limited in any manner and no case against seller Beeaar Autowheels India Pvt Limited is pending or decided by the undersigned.
  9. The source of amount and details thereof are annexed hereinafter.
