

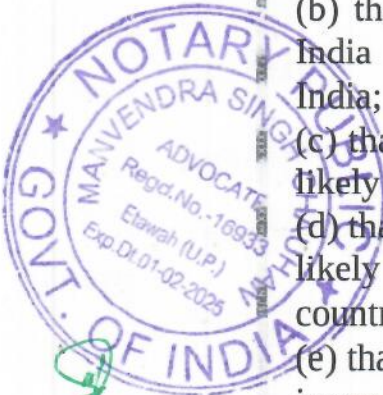

(h) that the applicant has not been repatriated;

(I) that there will be no possibility of arising embarrassing position before Government of U.P. due to my visit to any foreign country;

(J) that the issue of 'Identity Certificate' for obtaining a passport was never refused to the applicant;

(k) that the applicant has never visited any foreign country earlier.

That the particulars furnished by me above are correct and that I have not concealed or misrepresented any fact mentioned above.

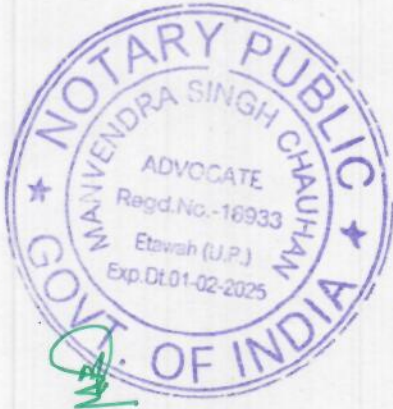
