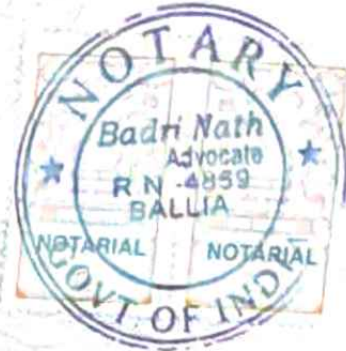

I, the deponent abovenamed, do solemnly affirm and state on oath as under:-

- a) that the deponent is a citizen of India.
- b) That the deponent may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India;
- c) that the departure of the deponent from India may nor, or is not likely, to be detrimental to the security of India;
- d) that the presence of the deponent outside India may not, or is not likely, to prejudice the friendly relations of India with any foreign country;
- e) that the deponent has, at any time during the period of five years immediately preceding the date of her application, not being convicted by a Court in India for any offence involving moral turpitude and sentenced in respect thereof in imprisonment for not less than two years.
- f) that proceedings in respect of any offence alleged to have not been committed by the deponent are pending before a criminal court in India;
- g) that it warrant or summons for the appearance, of a warrant for the arrest of the deponent has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the deponent has not been made by any such Court;
- h) that the deponent has not been repatriated.
- i) that in the opinion of the Central Government the issue of a passport or travel document to the deponent will be in the public interest.
- j) That issue of "Identity Certificate" for obtaining a passport to the deponent was never refused to the deponent.
- k) That the deponent has never visited any foreign country, till now.
- l) That my dependents are my daughters Amrasha Singh age 23 years and Archisha Singh age 18 years.
