

(a) that the applicant is a citizen of India;

(b) that the applicant may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India:

- (e) that the applicant has, at any time during the period of five years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years;
- (f) that proceedings in respect of any offence alleged to have not been committed by the applicant are pending before a criminal court in India;
- (g) that a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court;
- (h) that the applicant has not been repatriated.
- (i) that there is no possibility of arising any embarrassing position before the Government of U.P. due to applicant's visit to any foreign country.
- (j) that as regards any previous issue/refusal of Identity Certificate, it is stated that previously Passport no. L9825970 was issued in the name of the applicant on the basis of the Identity Certificate issued by the Hon'ble Court bearing Ref. No. 9832 Dtd. 20.07.2013 vide Letter no. 9832/IV-3503/Admin (A)/ Dtd. 20.07.2013. Now the reissue of passport is required in view of expiry of previous passport in near future and change in some details.

(k) that I have never visited any foreign country earlier.
