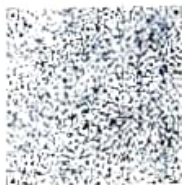

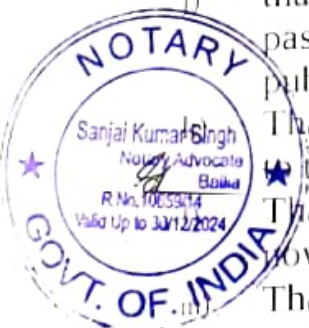

 - g) that a warrant or summons for the appearance, or a warrant for the arrest of the deponent has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the deponent has not been made by any such Court;

 - i) **That there is no possibility of arising embarrassment position before Government of U.P. due to my visit to any foreign country.**
 - j) that in the opinion of the Central Government the issue of a passport of travel document to the deponent will be in the public interest.
