No Claim Bonus will only be allowed provided the policy is renewed within 90 days of the expiry date of the previous policy.

Any payment made by the Company by reason of wider terms appearing in the Certificate in order to comply with the Motor Vehicle Act, 1988 is recoverable from the Insured.
