i) The issue of "identity Certificate" for obtaining a passport the deponent was never refused to the deponent.

j) That the deponent has never visited any foreign country, till now.

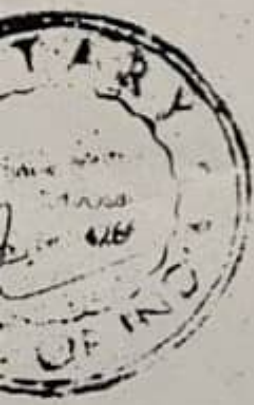
