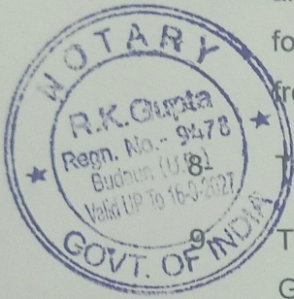


- 1- That the applicant is a citizen of India.
