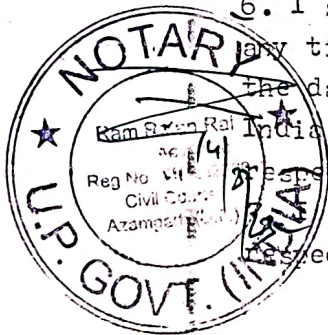

9. I solemnly affirm and state on oath that the applicant has not been repatriated.

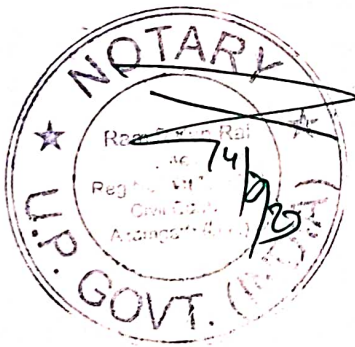
