Subject- **Grant of three advance increments on account of
having two years degree of L.L.M. from recognized
University.**

Respected Sir,

With reference to above subject I have the honour to submit that I have joined judicial service on 21.04.2009 and promoted to Civil Judge (Sr. Div) cadre on 15.10.2015 and in Higher Judicial Services on 20.08.2019. I have passed L.L.M. examination from Lucknow University in the academic session 1996. It was informed by Hon'ble Court's letter No. 14855/IV/Admin(A) dated 16.10.2014 that according to Govt. order and approval of Hon'ble the Chief Justice, three advance increments only be given to those Judicial Officers of U.P. Nyayik Sewa/ U.P.H.J.S., who have been selected on or after 21.03.2002 having two years degree of L.L.M. from a recognized University and the matter regarding grant of three advance increments who have been selected prior to 21.03.2002 having two years L.L.M. degree from a recognized University has been referred to the Government for reconsideration, by the Court.

I have applied for grant of three advance increments on ground of having two years L.L.M. degree from recognized University (Lucknow University) In terms of G.O. No. 8/2018/279/2-4-2018-45(12)/91 टी० सी० नियुक्ति अनुभाग- 4 लखनऊ दिनांक 13 अप्रैल, 2018 which has been issued in compliance of Hon'ble High Court's order dated 08.05.2017 and order of Hon'ble Court in some other writ petitions referred in aforesaid G.O. following orders are issued by Government on this subject:-

लागू हो, अथवा ऐसे न्यायिक अधिकारी, जो सेवा में आने के उपरान्त एल0एल0एम0 की उपाधि प्राप्त कर लेते हैं, उन्हें उपाधि प्राप्त करने के दिनांक से 03 अग्रिम वेतन वृद्धियां देय होंगी।

(3) उपर्युक्त अतिरिक्त वेतनवृद्धियों का लाभ संबंधित न्यायिक अधिकारियों की पदोन्नति/उच्च वेतनमान में जाने पर, जो भी स्थिति हो, मिलता रहेगा।

In view of above, it is humbly requested that this representation may kindly be presented before the Hon'ble Court for kind perusal and consideration for issuance of suitable order for grant of L.L.M. three advance increments to me from the date of joining i.e. 21.04.2009 on ground of having two years degree of L.L.M. from recognized University, in terms of the orders of the Hon'ble Court passed in three Writ Petitions followed by Government order dated 13.04.2018.
