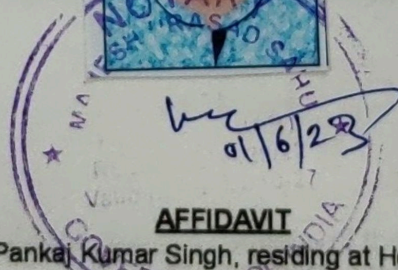

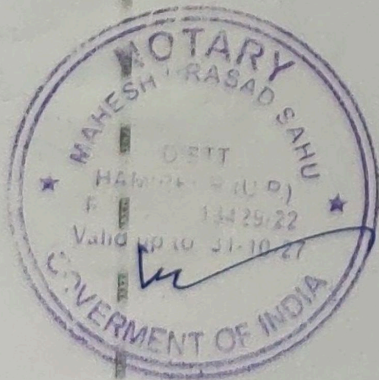

- (12.) That the applicant has never visited any foreign country earlier.

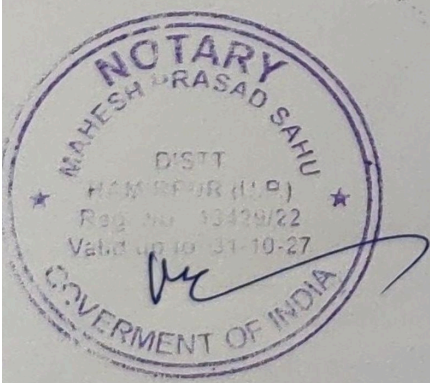
