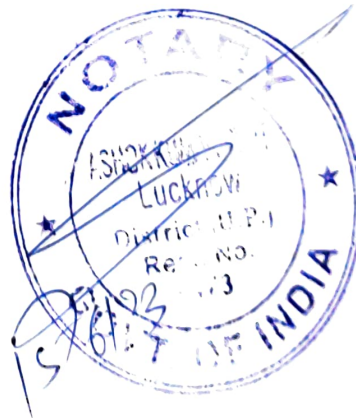

a- That the applicant is a citizen of India.

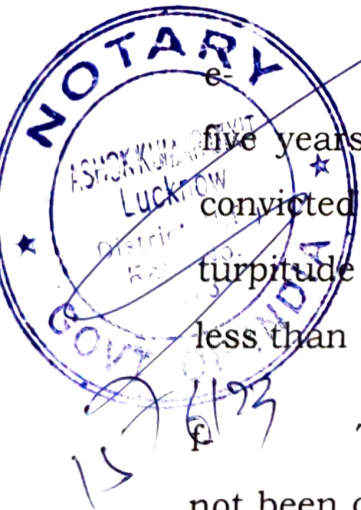
b- That the applicant may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India.
