



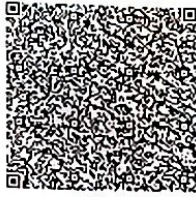

8. That a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.
9. That the applicant has not been repatriated.
10. That there is no possibility of arising embarrassing position before Government of U.P. due to her visit to any foreign country.
11. That issue of 'Identity Certificate' for obtaining a passport has never been refused to me.
12. That I have never visited any foreign country earlier.
13. That my dependent family members are (i) Muzain Hussain khan, age-9yrs (Son) (ii) Myrah khan, age 5 yrs (Daughter).
