UP 32 HB 3049 and chasis no. 165144 which was exchanged with the Maruti Company in true value worth Rs. 328500/- (ledger details are enclosed). I also wish to submit that the Loan amount of Rs. 500000/- taken against the old Maruti Swift Desire vxi car bearing registration no. UP 32 HB 3049 and chasis no. 165144 was repaid by undersigned and auto loan closure letter was issued by State Bank of India on 04.08.2023 (copy enclosed).

It is further submitted that the total cost of the new vehicle (Maruti Grand Vitara Smart Hybrid Delta 1.5L 5MT-GVR4DV1) is Rs. 1428500/- (Rs. 11000/- paid through cheque no. 218327, dated 07..08.2023 and Rs.1089000/- paid in cash through RTGS from my State Bank of India saving account no. 11189163026 on 09.08.2023). The total amount paid to the Maruti Company is – 328500+ 11000+1089000 = Rs. 1428500/- .


I, therefore, most humbly request that this information may kindly be placed before the Hon'ble Court for kind consideration.
