
Sir,

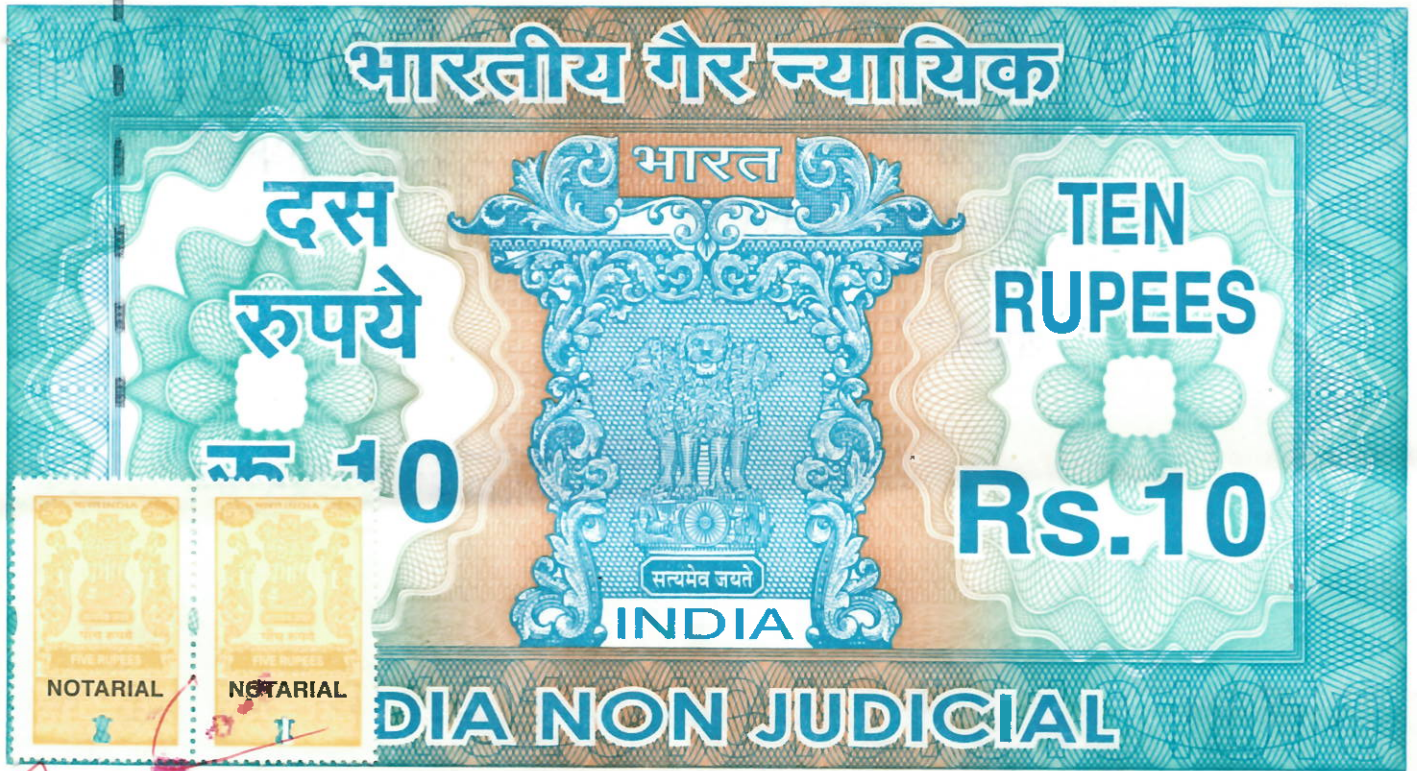
