Subject: Regarding objection on information about property purchase.

Respected Sir,

Kindly refer to my information about the purchase of HUDA property and your objection thereupon.

In this regard, I am enclosing herewith, the details of my earlier purchases as desired by you. These details are as follow.


(1) Residential Plot No-6B/44 (size 200 mtr.), purchased from UP Avas Vikas Parishad on 29.03.2011 at Moradabad with the help of loan sanctioned by LIC Housing and Finance Ltd. Detailed information of the said purchase was sent to Hon'ble Court vide letter no-987/2011 of Moradabad Judgeship dated 16.09.2011 (copy enclosed)

(2) Swift Dzire Car was purchased on 30.10.2013 in exchange of old Santro car and with the help of Rs. 2,50,000/- given by father. Detailed information of the said purchase was sent to Hon'ble Court vide letter no-363/I dated 26.02.2014 of Meerut Judgeship. (copy enclosed)

Further it is submitted that I have not purchased any immovable or major movable property after the aforesaid date i.e. 30.10.2013 Besides above the complete and attested copy of last 3 months passbook of my S/B Account is also enclosed herewith for your kind perusal as desired by you. It is also brought to your kind notice that the substantial payment for the purchase of HUDA plot was made by disbursement of a loan of Rs.14,84,000/- from the PNB Civil Lines Moradabad (copy of bank A/C statement enclosed). Prior to that periodical payments were made by me from

the salary account out of my savings and whenever I received arrears of LL.M. and interim relief of pay commission etc. RTGS/NEFT Receipts of the same, I have already enclosed with my information. Transaction number issued by my salary A/C Bank (SBI) and other details of money transfer are indicated on these receipts. Copies of Bank A/C Statements in respect of other payments including penalty etc. are also enclosed herewith. Compliance report in response of your objection is submitted as desired.
