Background of the Institution

INTRODUCTION

Swami Vivekanand Subharti University, Meerut (hereinafter referred to as the University or SVS University) was established by Government of Uttar Pradesh under the Swami Swami Vivekanand Subharti Vishwavidyala Uttar Pradesh Adhiniyam, 2008 (UP Act No.29 of 2008) (hereinafter referred to as the Act, copy placed at Annexure-1) as passed by the Uttar Pradesh Legislature and assented to by the Hon'ble Governor of Uttar Pradesh on September 04, 2008. On getting authorization from the Government of Uttar Pradesh (copy at Annexure-2), the University started functioning with effect from 15th September, 2008. The University has been recognized by the University Grants Commission under Section 2 (f) of the UGC Act, 1956.
