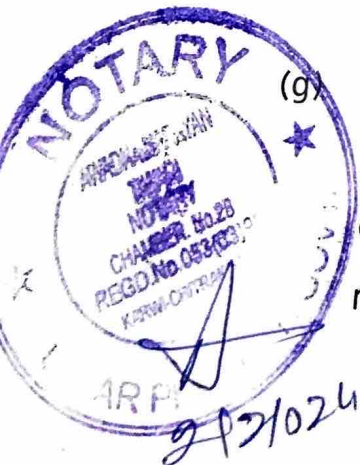

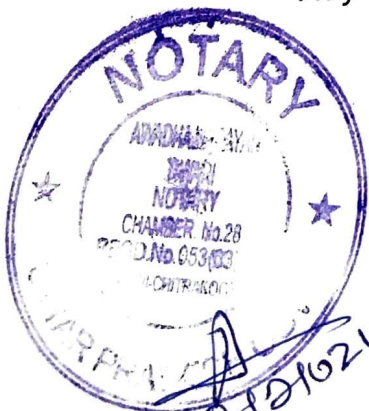
- (h) I have never been repatriated.


