
(ii) I am also submitting my four photographs in hard copy for the purpose of Identity Certificate. One of the above mentioned photographs has been attested by undersigned.

Aforesaid information is being furnished to your goodself for kind perusal and necessary action with respect to No Objection Identity Certificate.

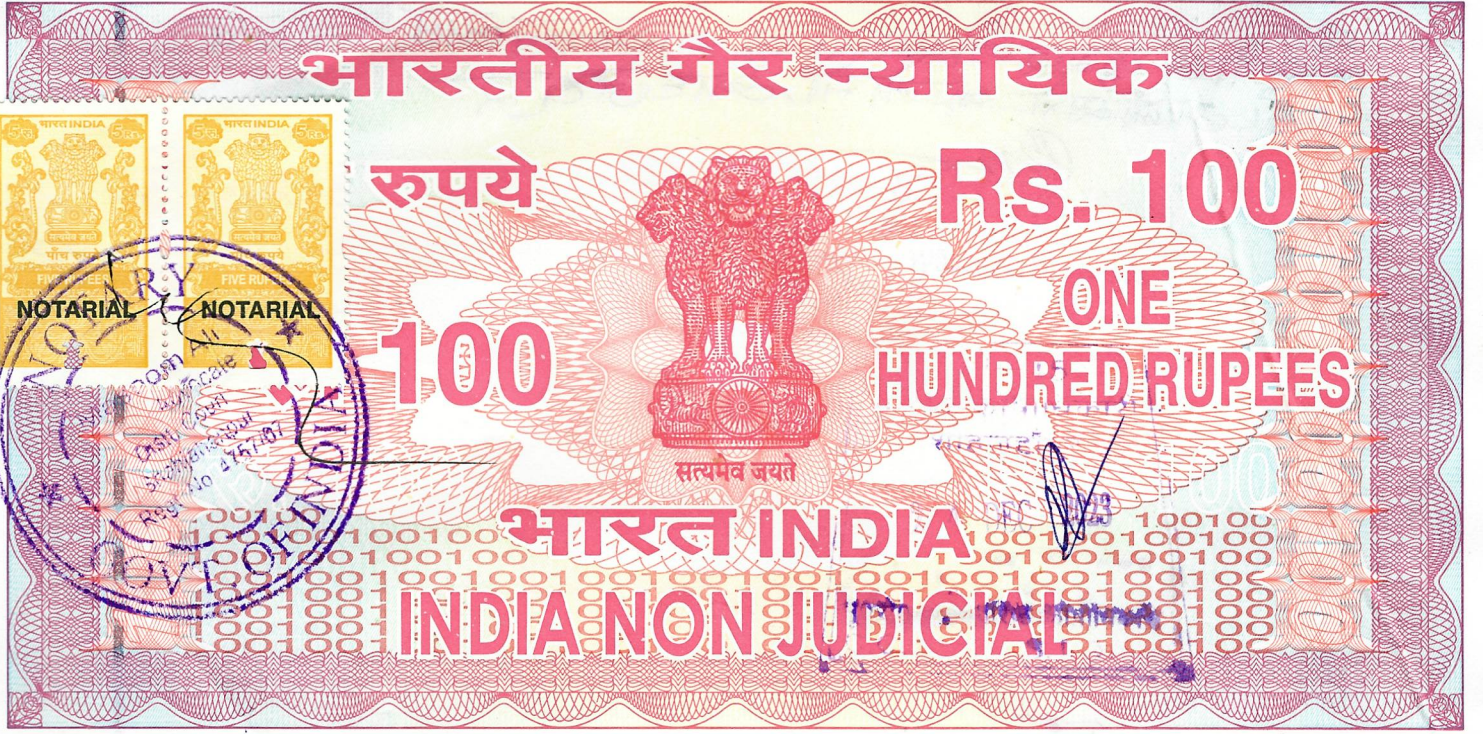

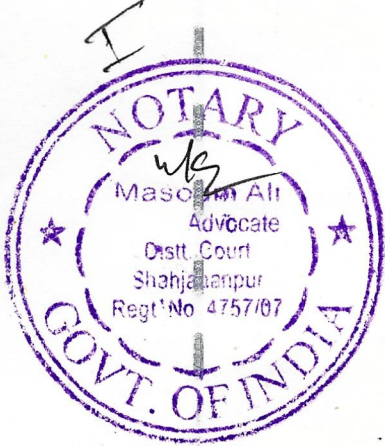

i- That there is no possibility of arising embarrassing position before Government of Uttar Pradesh due to his visit to any foreign country.

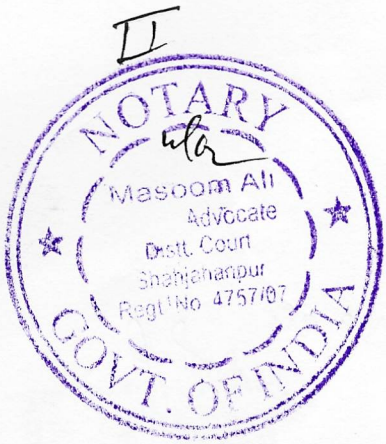

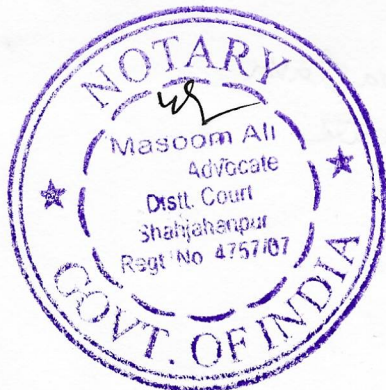
