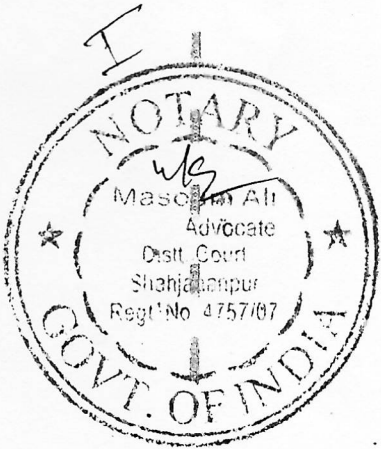

l- My wife Smt. Ashita Srivastava, my son Shivansh Srivastava and my daughter Ayushi Srivastava are dependents and family members as on date.

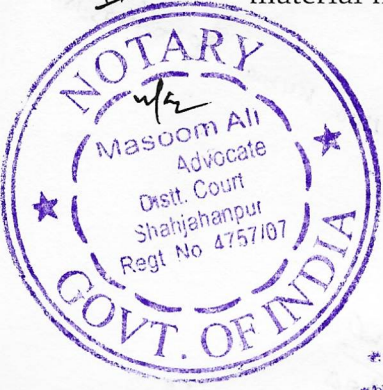

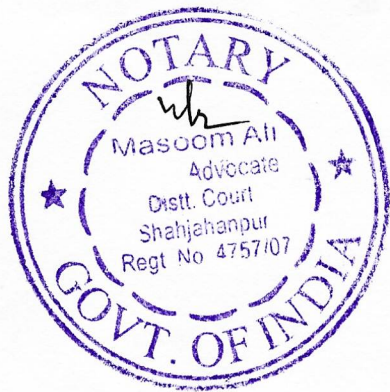
