Subject: Request for permission to apply for issue of Passport.


Respected Sir,

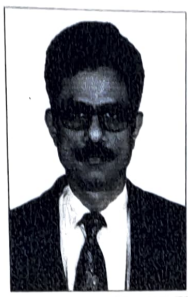
