

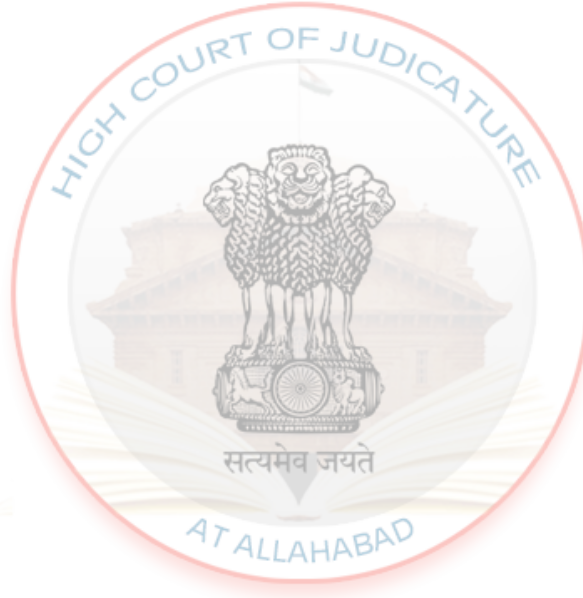

Further, the officer intimated the Hon'ble High Court and sought permission for appearing in the final semester examination after the completion of third semester.
