Sir,

With reference to your proposal submitted to UGC for recognition of Open and Distance Learning programmes from the academic session 2018-19 and onward. I am directed to inform you as under:-

1. As per Clause 4.10 of UGC [Categorisation of Universities (only) for Grant of Graded Autonomy] Regulations, 2018 "Universities may offer courses in the ODL mode, without approval of the Commission, provided it satisfies all the conditions laid down under UGC (ODL) Regulations, 2017 and amendments from time to time".
2. In view of the above, it is requested to submit an Undertaking in the form of notarised Affidavit indicating the following:
 - (i) Intention/declaration of the university to launch its programmes through ODL mode till the time, it is placed under Category-I;
 - (ii) declaration/intimation of score of NAAC CGPA;
 - (iii) declaration that university shall comply to all the conditions laid down under UGC (ODL) Regulations, 2017 and its amendments including that of providing all such information to UGC and displaying of all such information on its website.
