With all humility, the undersigned respectfully submits to your good self with regard to the subject cited above that –

- 1) That the undersigned had joined as Additional Civil Judge (J.D), Badaun on 1 March 2024 *Vide* notification no **399/admin(services)/2024 Dated 28/02/2024** by the order of Hon'ble High court of judicature at Allahabad . (ANNEXURE 1- Attached for your kind perusal)
- 2) That the undersigned has assumed **charge from 1 march 2024** as Additional Civil Judge (Junior Division) and the charge certificate is annexed herewith. (ANNEXURE 2 Attached for your kind perusal)
- 3) That *vide* letter no **3744/IV- 5633 (Loose)/ admin (A-4) Dated 21-03-24**, The undersigned, was allowed for appearing in the interview for the post of Civil Judge (Junior

Division) Jammu and Kashmir judicial services 2023. The copy of the *permission granted by Hon'ble High Court of judicature at Allahabad*, is annexed herewith. (ANNEXURE 3 Attached for your kind perusal)

- 4) That the undersigned got his final selection in the jammu and kashmir judicial services examination 2023 with Rank 15, The results were announced by jammu and kashmir public service commission *vide Notification no. PSC/EXAM/2024/04/DATED 03.04.2024*. (ANNEXURE 4 Attached for your kind perusal)
- 5) In Consequence to the result aforementioned, A medical test of the undersigned was conducted on **12 /04/24 at government medical college at Jammu**.
- 6) That the **approval list** was published by the department of law in pursuance to approval of His excellency Lieutenant Governor *vide Government Order No. 5864-JK(LD) of 2024. Dated. 03-05-2024*. (ANNEXURE 5 Attached for your kind perusal)

#### **Reason for Resignation -**

- 7) That the undersigned has been intimated that pre appointment training program Has already started from 9 MAY 2024, by the **Jammu and Kashmir Judicial Academy *vide notification no 112 / JKJA SGR***. (ANNEXURE 6 Attached for your kind perusal). On 13 / 04 / 2024 **Learned registrar general** of Jammu Kashmir high court and Respected Director of Jammu Kashmir judicial academy has intimated that Pre appointment training is mandatory for the issuance of Appointment letter and if undersigned Wishes to join jammu and kashmir judicial services then undersigned should immediately report to the judicial academy at Srinagar, Jammu and Kashmir. If undersigned fails to join the training, then Appointment letter will not be issued.
- 8) That the pre appointment training program is statutory and mandatory as per jammu and Kashmir judicial rules, 1967 for the purposes of appointment and postings thereafter.
- 9) That it is very necessary and urgent for the undersigned to resign with an immediate effect from Uttar Pradesh judicial services for the compliance of directions given by the concerned authorities of Jammu and kashmir High court

#### **Regarding notice period -**

- 10) That, the undersigned most humbly submits that due to the short notice from the judicial academy for joining pre appointment training programme , the undersigned is **not fulfill** the notice period of **one month** contemplated in **Rule 3 of Uttar pradesh Temporary government servants (Termination of services) Rules 1975 .**
- 11) That, As communicated by the Respected Registrar general of jammu and kashmir High court that the appointment letter will not be issued if undersigned fails to join the training programme.

12) That the above mentioned circumstances has left no other option with the undersigned other than resigning from the Uttar pradesh judicial services with immediate effect .

**Effective date of resignation -**

13) That undersigned, in the above-mentioned circumstances, resigns from the Uttar Pradesh Judicial Services with an immediate effect. And the **undersigned requests to consider my resignation effective from 15 May 2024** .





Whereas, the Department of Law, Justice & Parliamentary Affairs, vide letter No. Law-JUD/88/2021-10 dated 26.08.2023, referred 69 posts of Civil Judge (Junior Division), to the J&K Public Service Commission for being filled up through the Competitive Examination; and,

Whereas, these posts were advertised by the Commission vide Notification No. 35-PSC(DR-P) of 2023 dated 27.08.2023; and,

Whereas, J&K Civil Services (Judicial) [Preliminary] Examination-2023, was conducted on **08.10.2023** in which **3266** candidates appeared in full; and,

Whereas, as per the criteria fixed by the Commission, a total of 1162 candidates were declared to have qualified for the Mains Examination vide Notification No. PSC/Exam/S/2023/64 dated 13.10.2023; and,

Whereas, J&K Civil Services (Judicial) [Mains] Examination-2023 was conducted from 08.11.2023 to 20.11.2023; and,

Whereas, as per the criteria fixed by the Commission, 208 candidates were declared to have qualified for interview vide Notification No. PSC/Exam/S/2024/01 dated 06.03.2024; and,

Whereas, the viva-voce of these candidates was conducted w.e.f 19.03.2024 to 03.04.2024 at JKPSC Office, Resham Ghar Colony, Bakshi Nagar, Jammu; and,

Whereas, one candidate bearing Roll No.9100666 was not interviewed as the candidate failed to produce the EWS certificate. As a consequence, the candidate bearing Roll No.9101362, being next in order of merit, was called for interview under the said category; and,

Whereas, the Commission in its meeting held on 03.04.2024, decided to declare the result of the candidates who appeared in the interview by notifying their aggregate marks while publishing a list of the candidates to be summoned for Medical Examination in accordance with the relevant rules.






