- That the departure of the applicant from India may not, or is not likely to, be detrimental to the security of India,

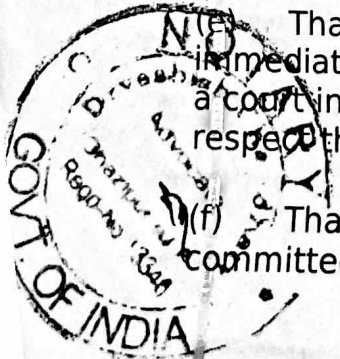

(g) That the warrant or summons for the appearance, or a warrant for the arrest of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court,

(h) That the applicant has not been repatriated,


(i) That there is no possibility of arising embarrassing position before Government of Uttar Pradesh due to his visit to any foreign country,


