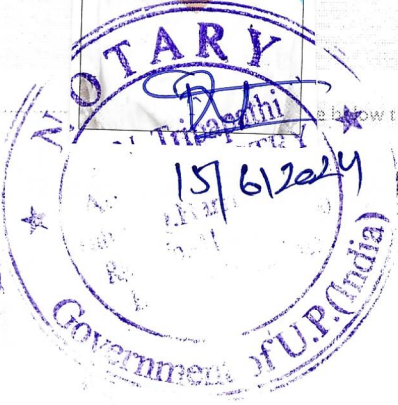
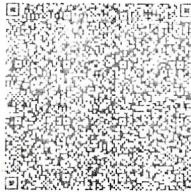

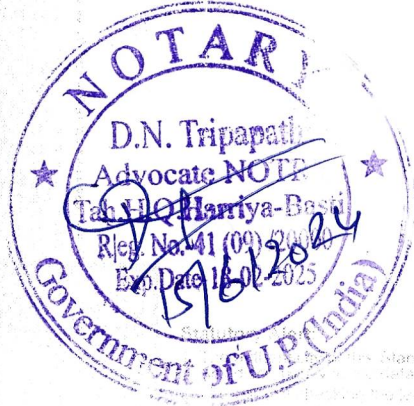

Affidavit U/S 6(2) of the Passports Act, 1967.

I, Zaiba Majid do hereby solemnly affirm and state on oath as under:

- (a) that I am citizen of India.
- (b) that I am not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India.
- (c) that my departure from India may not, or is not likely to be detrimental to the security of India.
- (d) that my presence outside India may not, or is not likely to, prejudice the friendly relations of India with any foreign country.
- (e) that I am at any time during the period of five years immediately preceding the date of my application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.
- (f) that no proceedings in respect of any offence alleged to have been committed by me, are pending before a criminal court in India.
- (g) that a warrant or summons for the appearance, or a warrant for the arrest, of me has not been issued by a court under any law for the time being in force or that an order prohibiting my departure from India has not been made by any such court.
- (h) that I have not been repatriated.
- (I) that there is no possibility of arising embarrassing position before Government of U.P. due to my visit to any foreign country.
- (J) that issue of 'Identity Certificate' for obtaining a passport was never refused to me.
- (k) that I have not visited any foreign country earlier.
