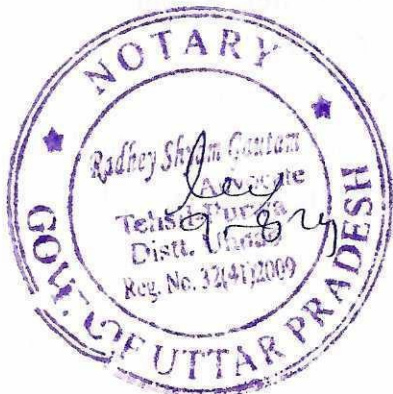



- (L) I have not visited foreign country earlier.


