The applicant was appointed as Civil Judge Junior Division in U.P. Nyayik Sewa Pursuant to U.P. Government Appointment/Notification no.-2430/II-4-06-32(1)/2001 T.C.-1 dated 26.05.2006 on the basis of vacancy advertisement No.-A-2/E-1/2003 dated 15.11.2003 and the applicant joined the aforesaid service by Hon'ble High Court Notification No 1137/DR(S)/2006 on 21.06.2006 as Additional Civil Judge Junior Division Basti. Therefore, the applicant is entitled to get benefits of **Old Pension Scheme**.
