

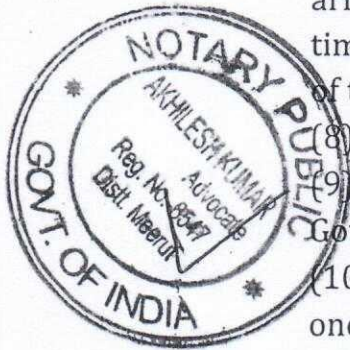
I, the above noted deponent do hereby solemnly affirm and state on oath as under-

- (1) That the applicant is a citizen of India.
- (2) That the applicant may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India.
- (3) That the departure of the applicant from India may not, or is not likely to, be detrimental to the security of India.
- (4) That the presence of the applicant outside India may not, or is not likely to, prejudice the friendly relations of India with any foreign country.
- (5) That the applicant has, at any time during the period of five years immediately preceding the date of the application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.
