
Sir,

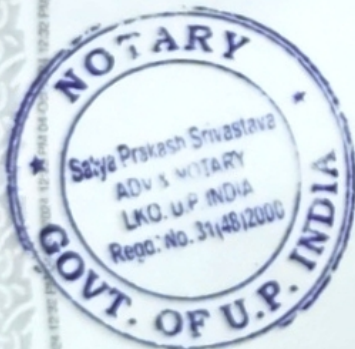
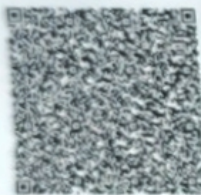

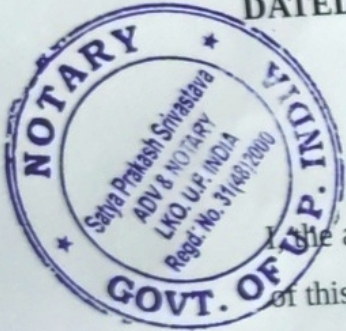
