<p><b>Admin A1(ADMIN A1)</b></p>	<p>Joint Registrar(J)(Budget) May kindly see letter dated 10.06.2020 alongwith attested copies of mark-sheets(all semesters) and degree of LL.M (online attached on 30.06.2020 at SL No. 05 &amp; 06) of Sushri Mrinalini Srivastava, Addl. Civil Judge (Jr. Div.) Sitapur, requesting for inclusion of LL.M qualification in her service-records. Sushri Mrinalini Srivastava, aforesaid, had earlier requested for inclusion of LL.M. Qualification in her service records vide District Judge, Sitapur endorsement no. 466/2020 dated 05.02.2020 (offline mode). Meanwhile, she has submitted online request dated 10.06.2020 for inclusion of subject qualification by uploading self attested copies of marksheets (all semesters) and LL.M. Degree. Thereafter, she has been requested vide office note dated Nil to upload attested copies of mark-sheets (all semesters) and LL.M. Degree accompanied with prayer for inclusion. Now, she has uploaded marksheets (all semesters) and LL.M. Degree (at SL No. 05 &amp; 06) online dated 30.06.2020 (online attached on 30.06.2020). In this context, it is submitted that Sushri Mrinalini Srivastava, aforesaid, joined U.P.Judicial Services on 18.01.2020 as Addl. Civil Judge (Junior Div.), Sitapur. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M(online attached on 30.06.2020), Sushri Mrinalini Srivastava, completed LL.M course in year 2019 and was subsequently awarded Degree from Lucknow University, Lucknow on 15.10.2019. Nevertheless, relevant detail about course completion is not mentioned in her application form of U.P.Nyayik Sewa, thus, said qualification is required to be included in her service records. It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sushri Mrinalini Srivastava , aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 10.06.2020 (online attached on 10.06.2020) of Sushri Mrinalini Srivastava, Addl. Civil Judge (Jr. Div.) Sitapur may be sent to the Government of U.P. for obtaining necessary orders. If approved, the matter may be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Sitapur, for kind perusal and order to the effect that copy of aforesaid letter dated 10.06.2020 along with attested copies of mark-sheets and degree of LL.M.
