<p><b>Admin A1(ADMIN A1)</b></p>	<p>Joint Registrar(J)(Budget) May kindly see letter dated 18.06.2020 alongwith attested copies of mark-sheets(both semesters) and degree of LL.M (online attached on 08.12.2020/ SL No. 04, 05 &amp; 06) of Sushri Nikita Sengar, Addl. Civil Judge (Jr. Div.), Hardoi, requesting for inclusion of LL.M qualification in her service-records. Sushri Nikita Sengar, aforesaid, had earlier requested for grant of Three Advance Increments vide District Judge, Hardoi endorsement no. 5/9/1-32.2020 dated 12.03.2020 (offline mode). Meanwhile, she has uploaded unattested copies of marksheets (both semesters) and degree of LL.M. On 18.06.2020 at SL No. 01, 02 &amp; 03. Thereafter, she has been requested vide online office note dated Nil to upload attested copies of marksheets (all semesters) and LL.M. Degree through eServicesJO portal for further necessary action. Now, she has submitted relevant documents online on 08.12.2020 (online attached on 08.12.2020/ SL No. 04, 05 &amp; 06). In this context, it is submitted that Sushri Nikita Sengar, aforesaid, joined U.P.Judicial Services on 16.11.2019 as Addl. Civil Judge (Junior Div.), Hardoi. Besides, as apparent from submitted attested copies of mark-sheet and degree of LL.M(online attached on 08.12.2020), Sushri Nikita Sengar completed LL.M course in year 2019 and was subsequently awarded Degree from Amity University, Noida on 09.11.2019. Nevertheless, relevant detail about course completion is not mentioned in her application form of U.P.Nyayik Sewa, thus, said qualification is required to be included in her service records. It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sushri Nikita Sengar , aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 18.06.2020(online attached on 18.06.2020) of Sushri Nikita Sengar, Addl. Civil Judge (Jr. Div.), Hardoi, may be sent to the Government of U.P. for obtaining necessary orders. If approved, the matter may be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Hardoi, for kind perusal and order to the effect that copy of aforesaid letter dated 18.06.2020 along with attested copies of mark-sheets and degree of LL.M. (online attached on 08.12.2020/ SL No. 04, 05 &amp; 06) as well as attested copy of form of U.P.Nyayik Sewa of Sushri Nikita Sengar, Addl. Civil Judge (Jr. Div.), Hardoi, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
