<p><b>Admin A1(ADMIN A1)</b></p>	<p>Joint Registrar(J)(Budget) May kindly see letter dated 30.06.2020 alongwith attested copies of mark-sheets(both years) and degree of LL.M (online attached on 12.01.2021) of Sushri Deeksha Bharti, Addl. Civil Judge (Jr. Div.), Lakhimpur Kheri, requesting for inclusion of LL.M qualification in her service-records and grant of three advance increments. Sushri Deeksha Bharti, aforesaid, had earlier requested for inclusion of LL.M. qualification and subsequent grant of Three Advance Increments vide District Judge, Lakhimpur Kheri endorsement no. 717/I-43-19 dated 30.06.2020. (offline mode). In the meantime, she also requested online for inclusion of same on 03.09.2020 uploading unattested copies of marksheets (both years) and degree of LL.M. (online attached on 03.09.2020). Thereafter, she has been requested vide court's online note dated 19.12.2020 to upload attested copies of marksheets and LL.M. Degree online through eServicesJO portal. Now, she has uploaded attested copies of mark-sheets(both years) and LL.M degree (online attached on 12.01.2021) accompanied with prayer for inclusion of LL.M qualification in her service-records and subsequent grant of of three advance increments vide letter dated 30.06.2020. (online attached on 12.01.2021) In this context, it is submitted that Sushri Deeksha Bharti, aforesaid, joined U.P.Judicial Services on 15.11.2019 as Addl. Civil Judge (Junior Div.), Lakhimpur Kheri. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M(online attached on 12.01.2021), Sushri Deeksha Bharti, completed LL.M course in year 2018 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.01.2019. Nevertheless, relevant detail about course completion is not mentioned in her application form of U.P.Nyayik Sewa/UPHJS, thus, said qualification is required to be included in her service records. It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sushri Deeksha Bharti , aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 30.06.2020(online attached on 12.01.2021) of Sushri Deeksha Bharti, Addl. Civil Judge (Jr. Div.), Lakhimpur Kheri, may be sent to the Government of U.P. for obtaining necessary orders. If approved, the matter may be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Lakhimpur Kheri, for kind perusal and order to the effect that copy of aforesaid letter dated 30.06.2020 along with attested copies of mark-sheets and degree of LL.M. (online attached on 12.01.2021) as well as attested copy of form of U.P.Nyayik Sewa of Sushri Deeksha Bharti, Addl. Civil Judge (Jr. Div.), Lakhimpur Kheri, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
