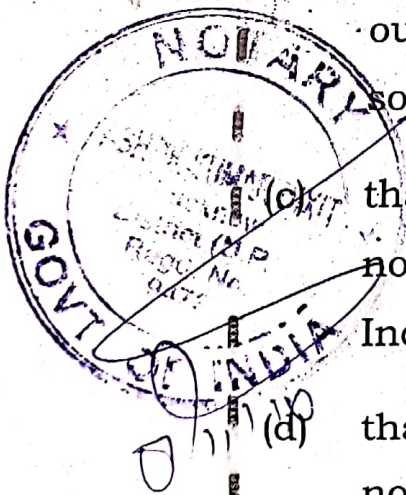

- (g) that a warrant or summons for the appearance , or a warrant for the arrest , of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court;
- (h) that the applicant has not been repatriated.
- (I) that in the opinion of the Central Government the issue of a passport or travel document to the applicant will be in the public interest.
- (j) that the applicant is having three family members namely:

Manoj Kumar Yadav- Husband

Nithik Yaduvanshi- son

Medhaush- son

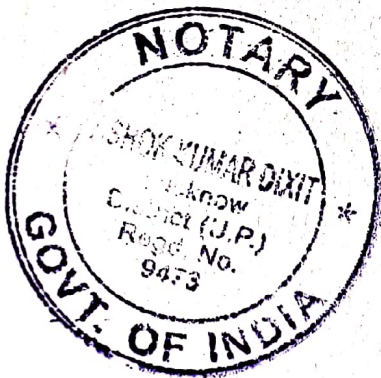
1- There is no possibility of arising embarrassing position before the Government of U.P. due to ;my visit to any foreign country.
