It is humbly submitted that my son Harshdeep Singh is pursuing his study in Computer Science (four years degree course) in Simon Fraser University, British Columbia, Canada and also does part time job in Canada and staying in rented house.

I want to go to Canada to visit my son in May-2020. Due to my visit to Canada will not affect any judicial work because a link officer is appointed for every Court for such exigencies. It is also submitted that, I have visited Canada last year from 08.06.2019 to 19.06.2019 with the permission of Hon'ble High Court and came back within stipulated time. That time, I also applied for visa to visit Canada and the same was granted to me with validity till 01.10.2026. Therefore, the applicant has valid visa to visit Canada. The applicant is submitting his application before time because the air ticket may be available at cheaper rate.
