

BOND OF AGREEMENT

- The terms and conditions of your appointment are subject to the policies and regulations of this Hospital owned and administered by the Medical Sisters of St.Joseph, Dharmagiri, a registered charitable society and are liable to be changed from time to time.
- Your appointment is on the total monthly-consolidated salary of Rs.20000/-(Rupees Twenty thousand only) per month payable by 3rd day of each completed months of service. Acceptance of gratification from patients and relatives is strictly prohibited. No other allowances shall be given/granted to employee by the employer. No advance salary/payment shall be given/granted.
- During your first probation of 4 months you will not be allowed any leave except weekly day off, after 4 months of your probation you will be entitled 12 days of casual leave, 8 days of festival leave, 10 days of medical leave if recommended by any of the consultants of the Hospital and 30 days earned leave after the completion of one year service. Casual leave may be availed of only for a minimum period of one day

and maximum period of five days at a time. The administrator will have the right to arrange any other day instead of Sundays or gazette holidays as holidays for you in order to maintain the Hospital functioning continuously.

Leave application should go through Med.suptd. and handover to the Administrator. If the leave is not applied properly and granted in advance it may be treated as absent from duty. No leave will be granted to you once you give the resignation letter.

- As Fatima Hospital is run and administered by the Congregation of the Medical Sisters of St. Joseph, a charitable society, you are hereby requested to serve this institution with great honesty, integrity and full dedication to grace the reputation of this hospital.
- You are requested to start your duty by 9.30 A.M. You shall go out only with the prior permission of the Administrator during duty hours if any emergency occurs.
- You and your family (husband/wife and children under 18 years) are eligible for free medical aid available in the Hospital, after completion of the first four months of your probation period. Food supplements, prophylactic medicines, treatment for infertility, Ophthalmology, Dermatology, Dental & Physiotherapy etc. are not included in the medical facilities. Leave for infertility treatment is not counted as sick leave.
- Giving one- month notice in writing from either side or one month's salary in lieu of the notice may terminate your service. In the event of
