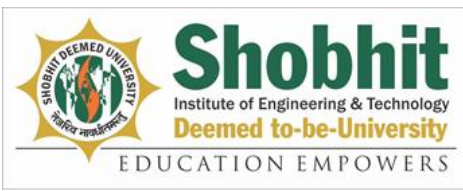

### Detailed Conditions for LL.M. (One Year Program)

I have the pleasure to inform that

- (1) Shobhit Institute of Engineering and Technology – Deemed to be University, Meerut is duly constituted and approved university by the UGC under Section 3 of the UGC Act, 1956 vide notification No. F.9-37/2004-U.3 (A) dated 8.11.2006.
- (2) The Academic Session for the Program is 2021-22.
- (3) The LL.M. (One Year) Program is a full time regular course being offered under the aegis of Centre for Post Graduate Legal Studies.
- (4) The Program is regular program and it is neither a Correspondence nor part time Course.
- (5) The mode of delivery of the lectures for the current academic session 2021-2022 shall continue to be online (virtual) on all working days and offline (physical) on all holidays including Sundays irrespective whether COVID-19 protocol restrictions continue to be in force or are relaxed or even withdrawn by the Government.
- (6) The Course has been designed as not to adversely affect the official discharge of duties of the Government Officials/Officers and Hon'ble Judicial Officers.
