Sub: Earnest Request for grant of permission for admission/appearing in the LL.M. Second Year/Final Year through the Directorate of Distance Education Kurushetra University, Kurushetra for the session 2021-2022.

Hon'ble Sir,

With reference to the aforesaid subject, it is to be humbly intimated that I had completed first year of LL.M. from Kurushetra University vide session 2010-2011 and my DDE Ref. No. is 6861. Though I was intended to complete the second year but in between that I had to appear in the Higher Judicial Services Examination of UP and other States and Advocates on record Examination of Hon'ble Supreme Court as well. At the same time, due to some urgent personal reasons, I could not complete my Second year of LL.M. Admittedly, it is my fault but the same was neither intentional nor deliberate but due to the reasons stated above. I am submitting following facts in this regard for your kind consideration:

1) That since it is a distance education Course(LL.M.) conducted through the Kurushetra University, Haryana. The examination for said course is scheduled to be held twice in a year in the month of June and December every year.

2) That for pursuing higher studies & then to seek permission for study leave is concerned, it is again humbly submitted that said course is conducted by the distance education and therefore, the question for seeking study

leave does not arise except for exams.

3) That pertinent to mention here that permission have been granted to me to appear in LL.M Final year examination by the Vice-Chancellor of Kurushetra University through Directorate of Distance Education for the session 2021-2022 vide **letter No.DDE/SE-II/DE-I/21/10286 dated 28/09/21** and further submitted that by the said letter it has also been intimated to me that I can seek admission in the said Course upto **30.11.2021**.


4) That once I get the permission for pursuing/appearing in the said course, the University Authorities also will not face difficulty to consider my candidature to take admission and appear in the said cours for the academic session 2021-2022.

Further, humbly submitted that I undertake that the Court work will not suffer and I am not intended to study during court hours in any eventuality.

I therefore, make a humble request to grant me the permission **prior to 30-11-2021** to take admission/appear in the LL.M. Second Year/Final Year Course through the Distance Education conducted by the Kurushetra University, Haryana **for the academic session 2021-2022**. For this act of kindness, I shall forever remain grateful to you and highly obliged.
