Short Title

Definitions

1.These rules shall be called "The GeneralRules(Civil)(Amendment), 2017"

Commencement and Application

- 2. (i) These rules shall come into force from the date of its publication in the official Gazette, (ii)These rules shall apply in all the courts, Subordinate to the High Court of Judicature Allahabad.
- 3. (i)The rules means "The General Rules (Civil), 1957".
- Amendment in rule 10 of Chapter I
- 4. The existing rule 10 of the rules shall be substituted as follows; "10.Daily sittings of Judges-The daily sittings of Civil Courts for Judicial work shall ordinarily extend from 10.30 a.m. to 4.30 p.m., with a recess from 1.30 p.m. to 2.00 p.m. and Judicial Officers shall so arrange the business of their Courts as to supply work for that time: Provided that a sitting may be prolonged by half an hour for the purposes of bringing to a conclusion the examination of a

conveniently interrupted.

There shall be no departure from this rule, except for special reasons of urgency, which must be recorded in the register of daily sitting".
