मुझे स्पष्ट कर दिया गया है कि इस गाड़ी की रजिस्ट्रेशन कार्यवाही डीलरशिप द्वारा, मेरे एवं फाइनेंसर के पूर्ण भुगतान के उपरांत ही की जाएगी। यदि मैं समय से भुगतान या रजिस्ट्रेशन के समस्त कागज नहीं पहुँचा पाता हूँ तो RTO Office की समस्त पेनल्टी की जिम्मेदारी मेरी होगी। साथ ही मुझे बता दिया गया है कि रजिस्ट्रेशन (RC) का कागज इस कार्यवाही के लगभग 25 दिन के अन्दर प्राप्त होगा।

मैंने वारण्टी के नियम अच्छी तरह समझ लिये हैं। मुझे बताया गया है कि डिलीवरी के बाद उपरोक्त गाड़ी में यदि कोई खराबी पायी जाती है तो गाड़ी बदलना सम्भव नहीं होगा। जिस पुर्जे में निर्माण दोष होगा केवल उसी पुर्जे को वारण्टी नियमानुसार बदला जायेगा। मुझे यह स्पष्ट है कि सेल्स प्रतिनिधि द्वारा किसी प्रकार का मौखिक वायदा मान्य नहीं होगा।

मुझे यह भी स्पष्ट रूप से बता दिया गया है कि टायर, ट्यूब, फ्यूल पम्प, सैल्फ, डायनमो, बैटरी आदि प्रोपराइटी सामान की वारण्टी मुझे उस सामान को बनाने वाली निर्माता कम्पनी से ही प्राप्त करनी होगी। उस सामान को मरम्मत करने या बदलने की जिम्मेदारी **मै. अरविन्द ऑटो सेल्स** की नहीं होगी। मैं मैसर्स अरविन्द ऑटो सेल्स को अधिकृत करता हूँ कि मेरे वाहन से सम्बन्धित सभी जानकारी के लिए मुझसे फोन पर बात या एसएमएस (SMS) कर सकते हैं।
