IMPORTANT INSTRUCTIONS FOR THE CANDIDATES

- You should bring this Admit Card daily to secure admission in the Examination Centres; otherwise you will not be allowed to enter the Examination Centre.
- 2. Your admission to the Examination is provisional subject to fulfillment of all the conditions of eligibility. If at any stage, it is found that you are not eligible, your candidature will be cancelled without any notice.
- Bringing of mobile phone, pager or any other electronic device and article such as books, notes and loose sheets etc. in the examination center is strictly prohibited. The candidates are strictly warned not to put on their digital/electronic or any other type of wrist watches or any type of Jewellery. If any candidate is found possessing such items in the Examination Centre, it will result in cancellation of candidature.
- You are to be present at the Examination Centre at least 30 minutes before the start of the Examination. You will not be admitted to the Examination Hall after half an hour of the start of the Examination.
- 5 Any change in the postal address should be communicated to the Secretary, HPSC at once.
- 6. You are also advised to read the instructions on the answer sheet as well as on the question paper and follow the same strictly.
- 7. Candidate must use only blue ink fountain pen or blue ink ball point pen to answer the questions. Candidates shall not be allowed to carry any other stationary
- 8. No candidate will write his / her roll number at any place other than the one prescribed on the answer sheet.
- Any marks including any religious marks on the answer sheet, whereby, an answer sheet can be identified to a particular candidate, is prohibited. 9
- Candidates shall not talk to each other during the course of the Examination. 10
- NO CANDIDATE SHALL BE ALLOWED TO LEAVE THE EXAMINATION HALL BEFORE THE EXPIRY OF FULL TIME. 11.
- 12. The answer sheet of the candidate using unfair means will be confiscated, and such candidate will stand disqualified.
- 13. No TA/DA shall be paid and there shall be no arrangement for boarding/lodging of candidates.
- 14. The Persons with Benchmark Disabilities (Blind and Low vision or Locomotor Disability) candidate who want the help of a scribe for writing his/her papers, will have to apply to the Commission for the permission of having a scribe separately well in time i.e. at least 07 days before the commencement of the examination
 - (ii) Extra time @ 20 minutes per hour will be given to those PwBD candidates who are using scribe or to whom extra time has been allowed by the competent authority.
 - The extra time will also be allowed by the competent authority, to those PwBD (Locomotor Disability) candidates in whose favour a medical certificate is issued by a Medical Board clearly stating that the candidates writing ability is severally effected due to his/her handicapness. No scribe or extra time will be allowed unless specifically granted by the Competent Authority.
 - (iv) No such permission to engage a scribe or for extra time shall be granted by the Centre Supervisor or any other person in the Examination Centre.
- 15. Candidates shall follow COVID-19 norms regarding Social Distancing, use of Mask and Personal Hygiene inside the Examination Halls as well as in the premises of the Examination Centres. Candidates would be suitably screened.

Note: The candidates are directed to bring one document as proof of their identity like Aadhar Card, Voter Card, Driving Licence, Pan Card, Passport etc. to be shown at the entry point of Examination Centre.
