Subject- Submission of information/ intimation regarding the purchase of movable property (Car) in accordance with the Rule 24 of the Government Servants Conduct Rules 1956.

Respected Sir,

I want to furnish the following information in the light of the **Circular Letter No. 25/ Admin. (A) dated 13th July, 1998** issued by the Hon'ble High Court of Judicature at Allahabad. Sir, I want to submit that-

1. I joined the Uttar Pradesh Judicial Services on 21st November 2019 vide notification No. 4015/ Admin. (Services)/ 2019 dated 14th November 2019.
2. I was getting a Gross Salary of Rs. 1,00,583/- (One Lakh Five Hundred Eighty-Three) during the Month of March/April, while the Take Home salary was Rs. 84,000 (Eighty-Four Thousands) at that period.
3. I have purchased a new car on 11.04.2022 named 'Hyundai Creta SX (1.5 CRDI MT)' from the reputed car manufacturing company 'Hyundai Motor India Ltd.' from its dealership showroom 'M/S Khanna Auto Sales Pvt. Ltd, Swaroop Nagar, Kanpur' located in Priyadarshini Nagar, District- Unnao. Sir, the total price paid by me for the purchase of above-mentioned car was Rs. 17,84,000/- (Seventeen Lakhs Eighty-Four Thousand Rupees).
4. I have not taken any advance or the Loan from the Hon'ble High Court.
5. I took a Car Loan of Rs. 13,00,000/- (Thirteen Lakhs) from the State Bank of India, Unnao Main Branch to pay the complete amount to the dealer. The Loan Account No. for the same is **40912753451**. The Loan EMIs are payable for 84 month (7 years) at Rs. 19,780/- (Nineteen Thousand Seven Hundred Eighty Rupees)/monthly. **(Shown in Annexure)**
6. I have purchased a new car.
7. The property purchased was a movable property of the description given in Point No. 3.
8. I have purchased the above-mentioned car from the reputed dealer "**Khanna Auto Sales Pvt. Ltd. (UP Country)**", having its **registered address-** 7/109-B, Swaroop Nagar, Kanpur Nagar. I purchased the vehicle from the dealer's Unnao Branch having the **Branch address-** 76/1, Priyadarshni, Priyadarshni Nagar Unnao.
9. Yes, the dealer is well known, reputed and regular Hyundai Car dealer of Kanpur Nagar and adjacent Districts.
10. No, the dealer is nowhere related to Me. And, I have not decided any case regarding the dealer concerned and no such case is pending in my court which is connected to the dealer.
11. I have made all the payments towards purchasing of the said vehicle from my Saving Bank Account No. 32761566223 of State Bank of India, Unnao City/Unnao Branch. The whole amount was paid in following manner:-
 - (i) Rs. 11,000/- (Eleven Thousand Rupees) paid in Cash as Advance.
 - (ii) 2 instant Transfers of Rs. 49,000/- (Forty-Nine Thousand) each were made using the QR Code of the dealership. Transaction ID Nos. 210112108620 & 210112122636 dated 11.04.2022. **(Shown in Annexure)**



- (iii) A Bank transfer of Rs. 3,75,000/- (Three Lakhs Seventy-Five Thousand Rupees) was made by the bank on my instructions from my Savings Bank Account No. 32761566223 to the Dealer's account on dated 11.04.2022. **(Shown in Annexure)**
- (iv) A Car Loan of Rs. 13,00,000/- (Thirteen Lakhs) was taken from the State Bank of India, Unnao Main Branch to pay the remaining amount to the dealer. **(As mentioned in Point No. 5 above)**

Sir, the information furnished with above- written content is being corroborated with annexed PDF copies of, **A.** Invoice issued by the Dealer, **B.** Delivery Challan issued by the dealer, **C.** Copy of E-passbook related to my Saving Bank Account No. 32761566223, showing the Statement of transactions from date 10.04.2022 to 12.04.2022. **D.** The Statement of Loan taken by me from the aforesaid branch of the State Bank of India situated at Unnao. **E.** The Registration Certificate issued by ARTO, Unnao regarding the purchased vehicle.

Sir, the delay if any, caused in sending this intimation is due to delayed issuing of the Registration Certificate by the ARTO, Unnao and delay caused on the part of dealer regarding issuing of the Vouchers and Receipts. Kindly, condone the same.
