He has also stated that he will not take study leave also. He has also enclosed the pass certificate related to his Ph.D. Course, which may kindly be seen as attachment. He has, therefore, requested to Hon'ble Court to grant him permission to submit his Ph.D. thesis to University of Lucknow. In this connection, it is stated that Sri Chaudhary has joined the U.P. Judicial Service on 03.03.2017. There is circular letter dated 4.11.11, which provides that if any Judicial Officer during the course of his Service, requests to pursue higher studies, he has to apply for grant of 'Study Leave' as per rules which will be subject to the discretion of Hon'ble the Chief Justice.
