1. That the deponent is a citizen of India by birth.

6. That the deponent has, at any time during the period of five years into immediately preceding the date of his application, not been convicted by a Court in India for any offence involving moral turpitude and sentenced in

respect thereof to imprisonment for not less than two years.

- 7. That no proceedings in respect of an offence alleged to have been committed by the deponent are pending before a Criminal Court in India.
- 8. That a warrant or summons for the appearance, or a warrant for the arrest of the deponent has not been issued by a Court under any law for the time being in force and any order prohibiting the departure from India of the deponent has not been made by such Court.
- 9. That the deponent has not been repatriated.
